- 3. 100% Silicone Roof Coating and 100% Silicone LS Roof Coating shall not be applied in inclement weather conditions.
- 4. 100% Silicone Roof Coating and 100% Silicone LS Roof Coating shall not be applied over asphaltic shingles, fiber-cement shingles, quarry slate, cement or clay roofing tile, or wood shingles or shakes.
- 5. The products listed herein are components of roof assemblies and are approved for use with roof assemblies that list any of the products listed herein as part of their roof assembly's Notice of Acceptance. For applications over existing single ply, granulated modified systems, refer to applicable building code for requirements.
- 6. - 9. Change in materials use, or manufacture of any of the products listed herein shall be cause for termination of this Notice of Acceptance.
- 10. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 61G20-3 of the Florida Administrative Code.
